UK Healers

In November 2003, UKH published the minimum Standards. They are available from BMSI and cost £5. The process of full legal recognition can now begin in earnest – it is all about regulation and transparency. Please see also the 'Grouping of Therapies' table.

Discussions with organisations not currently involved with UKH will take place in 2004. Any organisation not currently involved will still be subject UKH decisions.

CHO (Confederation of Healing Organisations)

CHO is being reformed following receipt of a large legacy of £400,000. Its objectives will be education and the promotion of healing. It will no longer be a training organisation offering the CBQ. That function is now the responsibility of UKH with the UKS (UK minimum Standards). Registered charities may apply for full membership for £52 per annum. Organisations not registered as charities will also be considered.

ECHO (European CHO)

This recently formed Confederation is making progress.

BAHA (British Alliance of Healing Organisations)

GROUPING OF THERAPIES

Briefing on the sixth report by the House of Lords Select Committee on Science and Technology.

As Complementary and Alternative Medicine includes a large number of therapies the Committee proposed three broad groupings based mainly upon its judgement about the available evidence for each therapy. The following 29 were put forward for possible self-regulation out of 46.

Department Of Health Sets Out Criteria For Recognition

Rebecca Sidwell, speaking on behalf of the Department of Health, outlined the Department's position on self-regulation at the Regulation Seminar at the King's Fund on 17 December 2003 (see also previous item). She made clear that there is no single blueprint - no 'perfect' solution. For each group self-regulation is about what is best for that group as a profession. There were however key features that the Department of Health would look for if the Department is to acknowledge any group as representing a particular profession.

UK HEALERS STANDARDS

UK Healers, which is a collaborative of healing organisations working towards self regulation, has now published in booklet form the standards agreed by the organisations involved. Forty three Healing organisations including BMS-IHF are now involved directly or indirectly in the work. The Standards Booklet includes sections on Membership, Training, Codes of Conduct, Healing – the Law, Assessment, complaints and Disciplinary Procedures and is available to the public from UK Healers, PO Box 4137, London W1A 6FE, price £5 including post and packaging.

Progress continues to be made. Following a colonoscopy examination on 9th March '04, no malignancies were found.

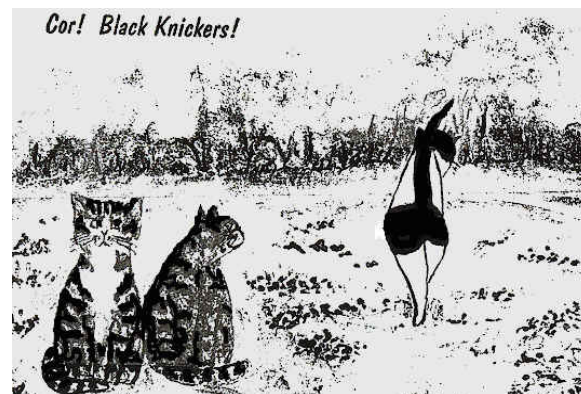
THE DATA PROTECTION ACT
